Carla stated yes, it was.

Scott: I noticed you got the Narcan box up. The kids have looked at it. But I am glad to report they have not brother it. So I am glad to say I was wrong.

Carla: I don't think we have any old business.

Brad: I have a question. Jose Isabell wanted to know if we have a map of the Sewer system. Andy said yes and he would try and get ahead of him tomorrow.
